Art On The Spot is for artists who create art while the customer waits. This may include caricatures, henna art, jewelry made to order, etc.

festival 2017 is being held on June 2, 3, 4, 2017 in downtown Grand Rapids
(festival of the arts is always held the first full weekend in June)

IMPORTANT CHANGES FOR 2017

Art on the Spot booth fees will be \$150 per 10x10 ft space. Where 2 artists work in the same booth, the fee is \$150 per artist. Festival will no longer collect an artist commission.

Artists wishing to participate in festival must meet the following criteria:

- Reside in one of these Michigan counties: Allegan, Barry, Ionia, Kent, Montcalm, Muskegon, Newaygo or Ottawa

festival provides:

- Electricity, if needed (no more than 25 amps allowed)
- Publicity
- Roving Security
- Lots of People!

Artists provide:

- Tent
- Display furniture and chairs
- Lights for individual booth, plus 100 feet of 12 gauge wire extension cord
- An "ABC" Fire extinguisher and a bungee cord to secure it to the tent (This is a City requirement. You will not be allowed to "open" your booth without a fire extinguisher.)

Logistics:

- Art On The Spot is located on Monroe Center in downtown Grand Rapids or on the lawn of the Federal Building off Ottawa Avenue.
- Sales hours will be advertised as:
Friday June 2 Noon to 9pm, Saturday June 3 10am to 9pm, and Sunday June 4 10am to 5pm

Entries

- **Must be postmarked NO LATER THAN February 28, 2017.**

ALL entry submissions MUST include the following items:

1. Completed application
2. \$20 Non-refundable Jurying Fee (made out to festival of the arts)
3. Photographs representing the type of art you intend to make and sell, preferably close-ups. Photos may be submitted on a disc. Samples of work are also acceptable. Work not represented at the time of jurying will NOT be permitted at festival. The jury reserves the right to exclude work submitted. You will be notified in writing which specific items or types of items are to be excluded. (If you would like your photos returned, include a self-addressed-stamped-envelope with your submission. Appropriate packaging and postage must also be supplied for return of any samples.)
4. A photo of your booth or display area.
5. Artist's statement which tells us something about you. This material may be used for festival publicity purposes.

Artist Booth Fees and Sales Tax information: Art on the Spot participants will handle their own money transactions. Michigan Sales Tax is the responsibility of the artist.

4. **Tell us about yourself;** an artist's statement, biography, photocopies of newspaper clippings, etc. If accepted, this material may be used for festival publicity.

Notification will be made by March 18, 2017.

Once you are notified of acceptance, Booth Fees MUST be received in full by April 18, 2017.
